Cold holding temperatures TCS food not maintained at 41°F or below milk on serving line 51°F return milk to freezer and replace store milk on serving line in ice</p> <p>CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.</p>
